## **Fees and Surcharges**

**Grave:** \$450 (25% to Key Bank perpetual care investment fund (\$112.50)

**Opening:** Adult or Child \$850 to excavating co.

Infant \$300 to excavating co.

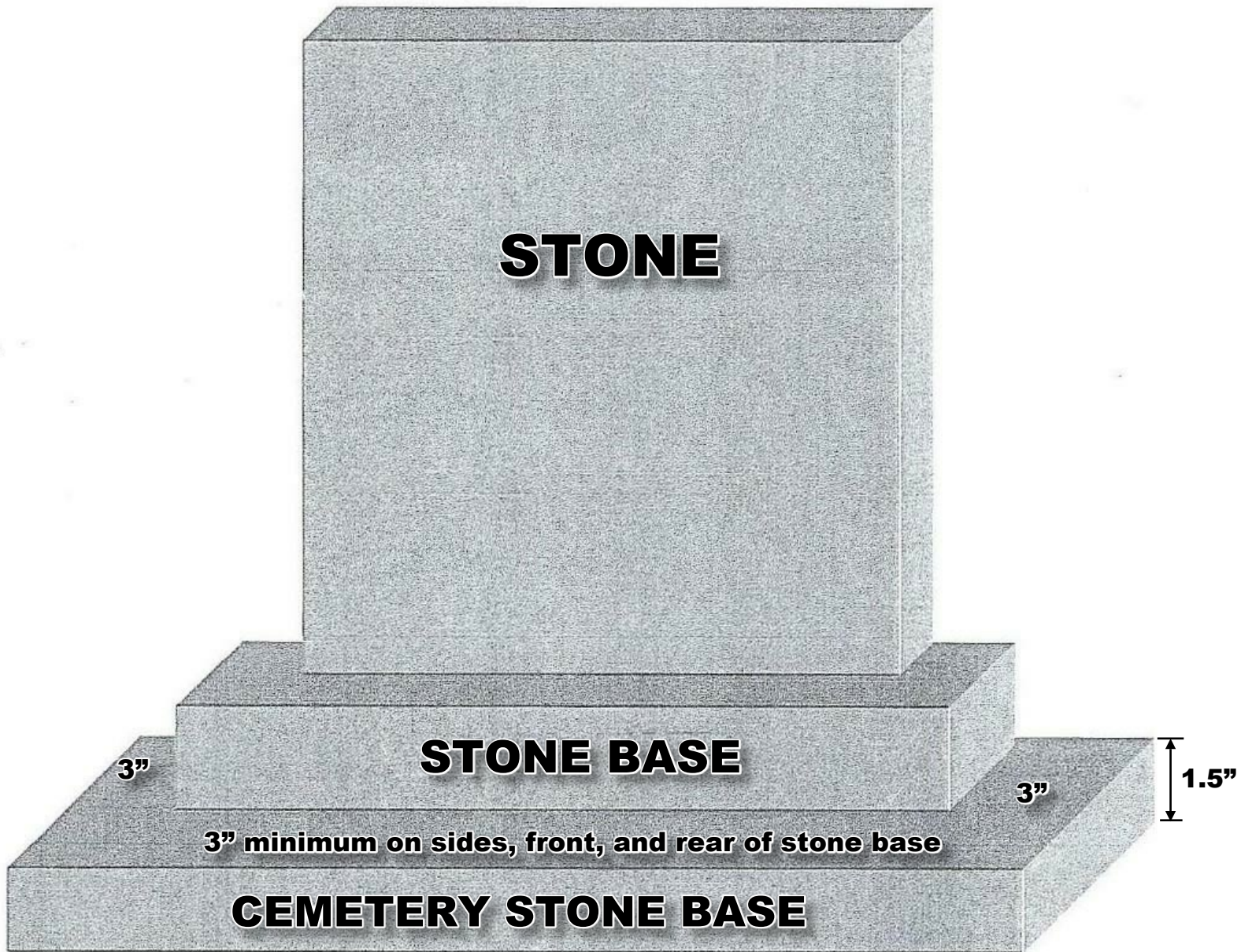
**Cremated Remains:** \$150 to relevant cemetery

**Surcharges:** Funeral services office charge \$100 to parish

Cemetery services processing fee, grave site clean up, and seeding: \$130 to respective cemetery

**Labor:** For any other services requested of our cemetery staff: \$20/hr. plus cost of supplies

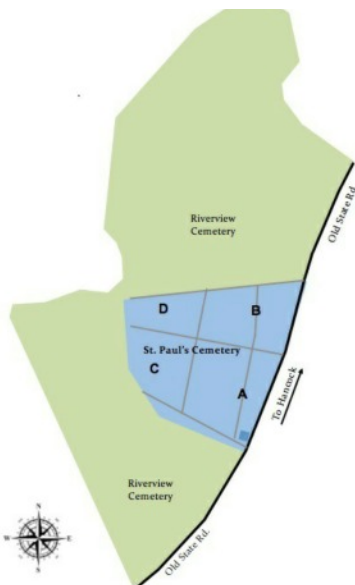
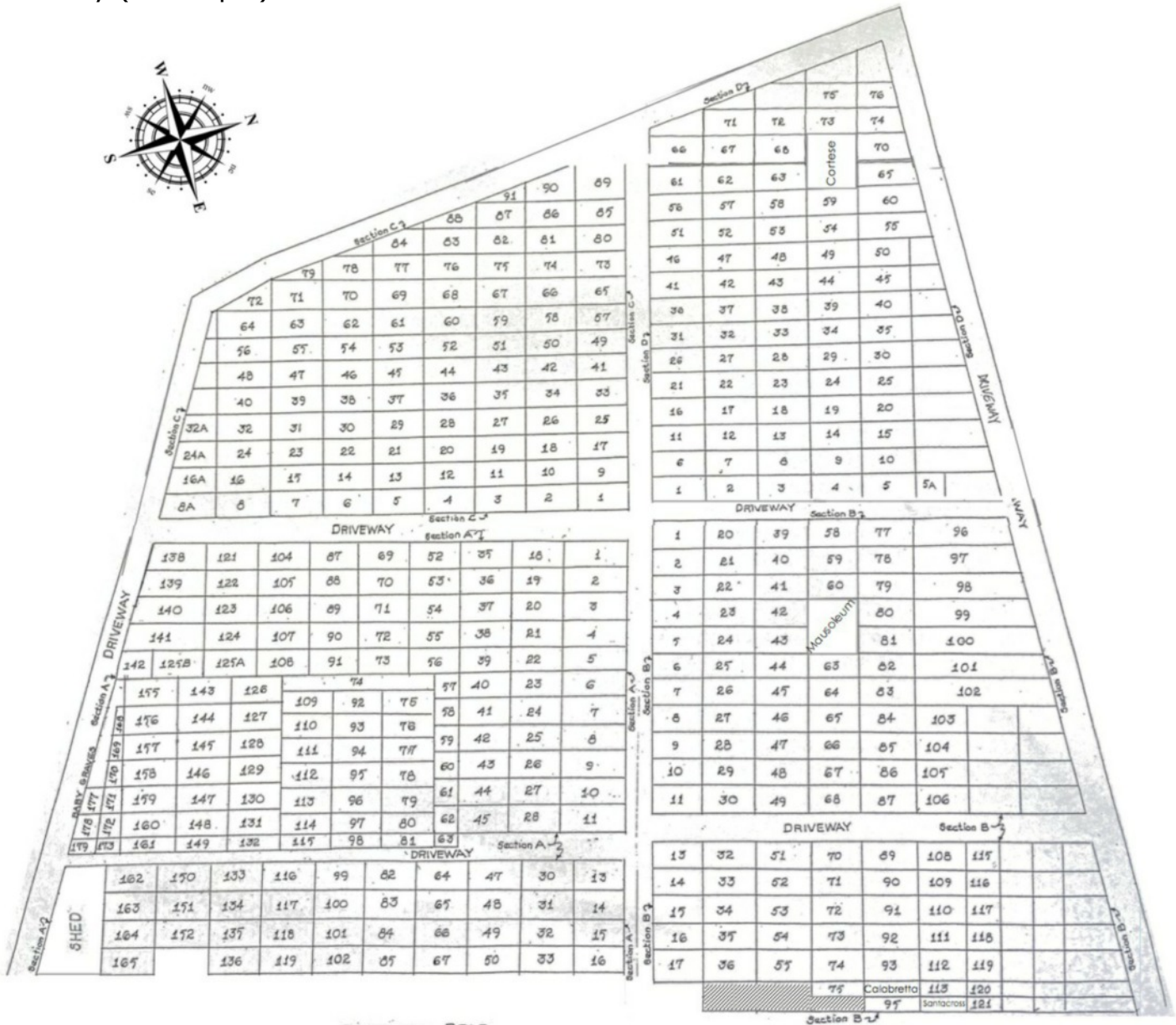

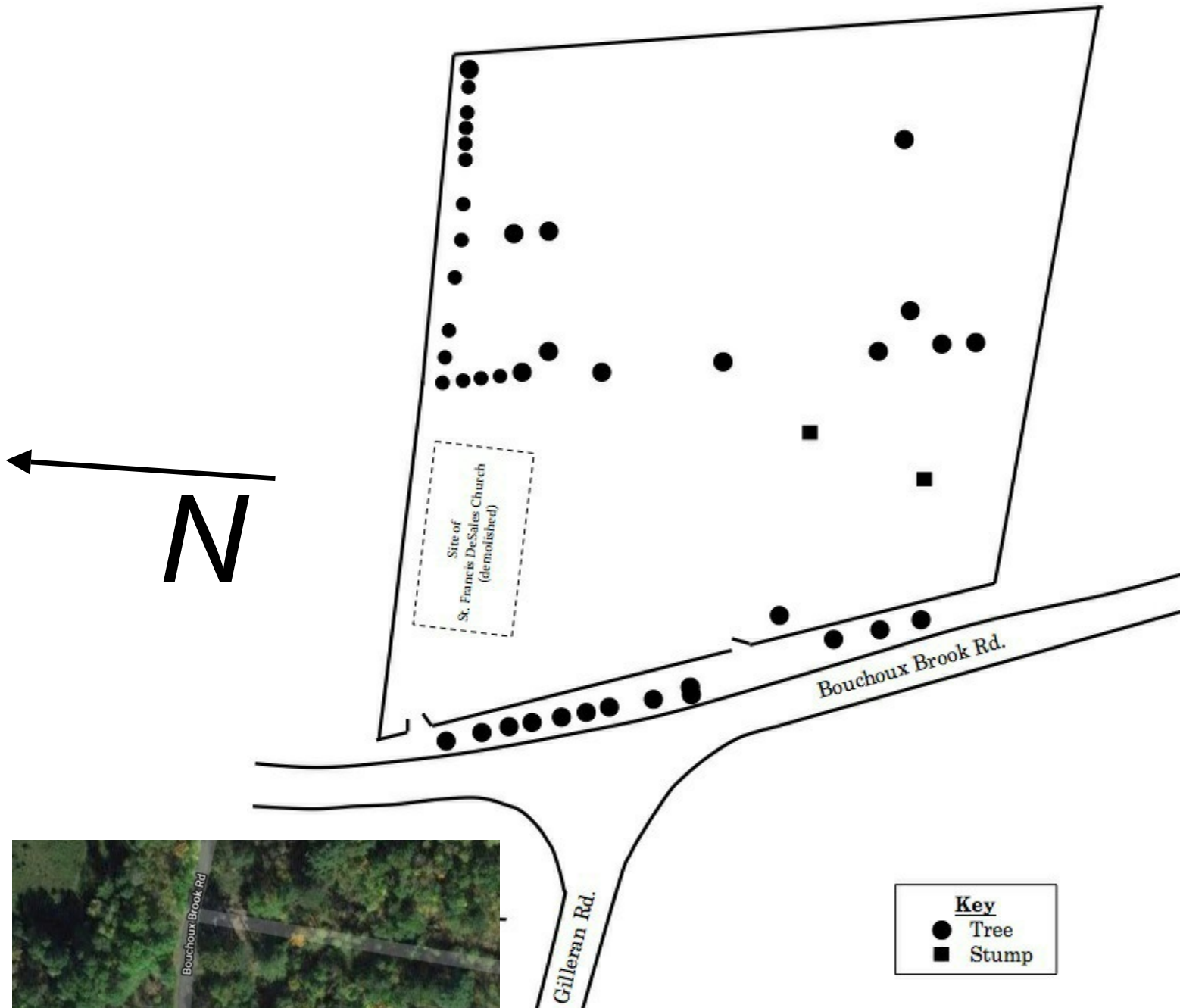
# St. Paul the Apostle Cemetery
